How to Apply

To apply for CLE credit for any one or more of these sessions, you will **need to go online** and complete the application form that DRI has posted at the following URL:

In addition, **if you wish to apply for CLE credit in either California or New Jersey**, you will need to manually sign into and sign out of the relevant sessions. To facilitate that process, AGC will put separate sign-in sheets for California and New Jersey on a table at the back of the relevant rooms.

Follow-Up

Once you complete and submit the online form, DRI will send you an email confirming that you have applied for CLE(s) credit and providing you with a certificate of attendance. The email will also advise you of any additional steps that you may need to take (depending on the state(s) to which you are applying for credit). In some cases, DRI will submit your certificate of attendance for you. In other cases, you will need to self-submit. In still other cases, you will simply need to retain a copy of your certificate.

Deadline

The **hard deadline** for completing and submitting an application for CLE credit is **February 21, 2020**.
